Dear Ms. Bose:

In accordance with the requirements of the Interstate Commerce Act and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC"), Hiland Crude, LLC ("Hiland") submits for filing the following tariff, effective April 1, 2020:

- FERC Tariff No. 13.2.0, Double H and Market Center Gathering System Joint Tariff with Tallgrass Pony Express Pipeline, LLC, applying on interstate transportation of crude petroleum (cancels FERC Tariff No. 13.1.0).

On August 1, 2019 as amended on August 13, 2019, in Docket No. IS19-730-000 Hiland and Tallgrass Pony Express Pipeline, LLC ("Carriers") filed a new joint committed rate for shippers that had entered into throughput and deficiency agreements for a minimum volume commitment over at least a five year period. Hiland justified the new joint rate filing on the grounds that the joint rates were less than or equal to the sum of the applicable existing local rates for each carrier involved in the joint movement and supported by at least one unaffiliated shippers. Hiland is filing FERC Tariff No. 13.2.0 to include the committed "B" rates for shippers that had entered into throughput and deficiency agreements for a minimum volume commitment over at least a five year period. The committed "B" joint rates are less than or equal to the sum of the applicable existing local rates for each carrier involved in the joint movement and supported by at least one unaffiliated shipper. Pursuant to 18 C.F.R. § 342.2(b) (Establishing Initial Rates) Hiland is filing this tariff with a sworn affidavit that the joint committed rates set forth in FERC No. 13.2.0 are agreed to by a least one non-affiliated entity that intends to use the service. There are no changes to the previous filed committed "A" rates in this filing; only minor format changes to reflect cents per barrel. Tallgrass Pony Express Pipeline, LLC concurs with this joint tariff filing, and the contact for Tallgrass Pony Express Pipeline, LLC is L.
