

The above tariffs have been filed under the authority of 18 CFR 341.6 (c). Effective March 8, 2007 Dome Pipeline LLC became the Kinder Morgan Cochin LLC. All rates, routes, rules and regulations and conditions of service have been brought forward unchanged from the previous Dome Pipeline LLC tariffs being adopted.

Kinder Morgan Cochin LLC seeks special permission to file under the authority of 18 CFR 341.14 on less than one days' notice since a number of changes in name or ownership occurred so quickly in succession making it impossible to provide 30 days notice in order to bring the documents forward and have them adopted. Less than one days' notice will allow the documents to be superseded to reflect the current carrier information yet show the transition in the name and ownership of the carrier and allow all documents to become effective as soon as possible in compliance with the requirements of 18 CFR 341.6 (c).
