2007 Contested Settlement Information Requests**

The Board acknowledges receipt of the letter dated 5 April 2007 from Kinder Morgan Cochin ULC (Cochin) informing of continuing discussions between Cochin and Spectra Energy Empress L.P. (Spectra) to reach a settlement of 2007 rates. In the letter Cochin requests that the Board extend the deadline for Cochin to respond to the Board's request for information dated 30 March 2007.
