Dear Secretary Bose:

In accordance with the requirements of the Interstate Commerce Act (ICA) and the Rules and Regulations of the Federal Energy Regulatory Commission (F.E.R.C.), Kinder Morgan Cochin LLC ("KM Cochin Portland") submits for filing the following tariff, effective December 21, 2018:

- F.E.R.C. Tariff No. 62.1.0, Rules and Regulations (cancels F.E.R.C. Tariff No. 62.0.0)
- F.E.R.C. Tariff No. 63.9.0, Local Rate Tariff (cancels F.E.R.C. Tariff No. 63.8.0)

KM Cochin Portland operates an approximately 8.5 mile turbine fuel line that extends from a marine terminal in Portland, OR to the Portland International Airport in Portland, OR. KM Cochin Portland acquired and took over operatorship of the system on July 31, 2009. Since January 1, 2010, which is shortly after KM Cochin Portland took over operatorship; no volumes have been nominated or transported under KM Cochin Portland's F.E.R.C tariffs. Since January 1, 2010, all turbine fuel has been and is being transported under KM Cochin Portland's Local Intrastate Tariff per the discretion and intent of the shippers, as all turbine fuel volumes that are transported on the line to the airport have previously come to rest in storage tanks in Portland, OR. Therefore, pursuant to 18 CFR § 341.5, KM Cochin Portland is filing these revised tariffs to cancel its F.E.R.C tariff rules and regulations and local rate tariff for transportation of turbine fuel. All current and future turbine fuel shippers will continue to be able to make intrastate movements on the system to the Portland International Airport, as they do today, under KM Cochin Portland's Local Intrastate Tariff.
