

EXTENSION - Cowboy Midstream, Hiland Crude and Plains Pipeline, announce open season between Dore, ND and Casper, WY

Houston, TX – January 5, 2024 –Hiland Crude, LLC (Double H), a subsidiary of Kinder Morgan, Inc., Cowboy Midstream, LLC, and Plains Pipeline L.P. are conducting an open season for crude oil transportation commitments on the Double H pipeline system, Powell Lateral, and North Rocky Mountain System between Dore, North Dakota and Casper, Wyoming in exchange for volume incentive tariff rates.

The open season will be managed by the law firm of CBL Energy Law, PLLC and will begin on January 5, 2024 and **end at 5 p.m. Mountain Time on February 15, 2024**.
