Dear Secretary Bose:

In accordance with the requirements of the Interstate Commerce Act and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC"), Cypress Interstate Pipeline LLC ("Cypress") submits for filing the following tariffs, effective July 1, 2020:

- FERC No. 8.11.0, local interstate tariff applying on purity ethane and commercial ethane transportation (cancels FERC No. 8.10.0); and
- FERC No. 9.12.0, volume incentive tariff applying on purity ethane and commercial ethane transportation (cancels FERC No. 9.11.0).

Cypress makes this filing pursuant to 18 C.F.R. § 342.3, Indexing. The attached table of Tariff Schedule Changes contains the information required by 18 C.F.R. § 342.3(b), including the rate schedule to be changed, the proposed new rate, the prior rate, the prior ceiling level, and the applicable ceiling level for the movement for the period July 1, 2020 to June 30, 2021. As demonstrated in the table, Cypress is proposing to raise the rates in the tariffs specified herein to a level that is below the applicable ceiling level.

In addition, Cypress is updating the compiler information in the tariffs.
