Dear Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act (ICA) and the Rules and Regulations of the Federal Energy Regulatory Commission (FERC), Hiland Crude, LLC Double H Pipeline (Double H) submits for filing the following tariffs, effective July 1, 2025:

- FERC Tariff No. 8.21.0, Local and Proportional Tariff applying on interstate transportation of crude petroleum on Double H (cancels FERC Tariff No. 8.20.0); and
- FERC Tariff No. 12.13.0, Volume Incentive Tariff applying on interstate transportation of crude petroleum on Double H (cancels FERC Tariff No. 12.12.0); and
- FERC Tariff No. 13.9.0, Market Center Gathering System and Hiland Joint Tariff with Tallgrass Pony Express Pipeline, LLC, applying on interstate transportation of crude petroleum (cancels FERC Tariff No. 13.8.0).

**I. Explanation of Tariff Filing**

Double H is filing these tariffs in anticipation of the conversion of the Double H Pipeline system early next year to natural gas liquids service. However, some origins and destinations will remain in place until the crude oil can be removed from the system.

In FERC Tariff No. 8.21.0, only the origins and destinations identified in Table 2 will remain and still be active July 1, 2025. Also, Tariff No. 8.21.0 removes Albin Station as an origin in Table 2.

Double H is cancelling FERC Tariff No. 12.13.0 Volume Incentive Tariff because there are no longer any active agreements under this tariff.

Hiland is filing FERC Tariff Nos. 13.9.0 to remove the Albin Terminal origin that is no longer available for service. Hiland, the owner and operator of both Market Center Gathering and Double H Pipeline and concurs FERC Tariff No. 13.9.0 is a joint tariff. The contact for Double H Pipeline LLC is Chris Ebright.
