Dear Secretary Bose,

The accompanying Kindergarten Morgan Utopia LLC (“Utopia”) tariffs, issued on October 1, 2021, to be effective on November 1, 2021, are sent to you for filing in compliance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission (“FERC”).

- **FERC Tariff No. 1.1.0**, general rules and regulations tariff, governing the transportation of purity ethane (cancels FERC Tariff No. 1.0.0)
- **FERC Tariff No. 6.0.0**, new international joint volume incentive rate tariff applying to transportation of purity ethane

FERC Tariff No. 1.1.0 is a rules and regulations tariff (the “Utopia Rules Tariff”) and is filed under authority of 18 CFR 341.3(b)(6). The Utopia Rules Tariff contains a revision to *Rule 6 – Tenders and Quantities* to allow for the delivery at the Delivery Point of less than the 5,000 Barrel per day minimum batch size when the Carrier specifies in a rate tariff a lower minimum quantity of Barrels per day to be delivered at the Delivery Point. No other changes have been made to the Utopia Rules Tariff other than to update references to other tariffs where applicable and to correct a Rule reference in the definition of “Financial Assurances”.

FERC Tariff No. 6.0.0 is a new international joint volume incentive rate tariff, filed on behalf of Kindergarten Morgan Utopia Ltd. and Kindergarten Morgan Utopia LLC, for service from Harrison County, Ohio to Windsor, Ontario. This new joint volume incentive rate tariff allows shippers to move on a month to month basis an average minimum of 1,000 Barrels per day up to an average of 10,000 Barrels per day for a joint incentive rate. This joint incentive rate is at or below the sum of the local rates shown in Utopia FERC Tariff No. 2.4.0 and Kindergarten Morgan Utopia Ltd. Canada Energy Regulator (“CER”) Tariff No. 11. FERC Tariff No. 6.0.0 also contains specific rules and regulations that apply in addition to the rules and regulations in FERC No. 1.1.0, which are located in Rule 45

of FERC No. 1.1.0. FERC Tariff No. 6.0.0 will be submitted concurrently to the CER as CER Tariff No. 13. A schedule showing the sum of the local rates for the joint movement is attached hereto.
