Dear Secretary Bose:

In accordance with the requirements of the Interstate Commerce Act and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC"), Products (SE) Pipe Line Corporation (PPL) submits for filing the following tariffs, to be effective July 1, 2022:

- FERC No. 155.35.0, Local, Proportional, and Volume Incentive Tariff (cancels FERC No. 155.34.0)
- FERC No. 156.22.0, Joint and Volume Incentive Tariff with Marathon Pipe Line LLC (cancels FERC No. 156.21.0) and
- FERC No. 159.4.0, Committed Rate Tariff (cancels FERC No. 159.3.0)

PPL is making this filing in compliance with 18 CFR § 342.3, Indexing. The attached table of Tariff Schedule Changes contains the information required by 18 CFR § 342.3(b), including identification of the rate schedule to be changed, the proposed new rates, the prior rates, the prior ceiling levels, and the ceiling levels applicable for the period from July 1, 2022 to June 30, 2023.

FERC No. 156.22.0 is a joint tariff with Marathon Pipe Line LLC. As shown in the attached Joint Rate Justification Table, the joint rates are equal to the sum of the local rates on file with the FERC in Marathon's FERC No. 302.13.0 and PPL's FERC No. 155.35.0. 
PPL notes that it is revising the committed rates set forth on FERC No. 159.4.0 in accordance with the provisions of the underlying transportation services agreement.
