Dear Secretary Bose:

In accordance with the requirements of the Interstate Commerce Act ("ICA") and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC" or "Commission"), SFPP, L.P. ("SFPP") submits for filing the following tariff, effective July 1, 2021:

- FERC Tariff No. 195.13.0, local tariff covering interstate transportation from Sepulveda Junction to Watson, California (cancels FERC Tariff No. 195.12.0);
- FERC Tariff No. 196.23.0, local tariff covering interstate transportation from Watson and East Hynes, California to Calnev Pipe Line, LLC (cancels FERC Tariff No. 196.22.0);
- FERC Tariff No. 197.19.0 local tariff covering interstate transportation from El Paso and Diamond Junction, Texas, to Lordsburg, New Mexico, and Tucson and Phoenix, Arizona (cancels Tariff No. 197.18.0);
- FERC Tariff No. 198.23.0, local tariff covering West Line interstate transportation (cancels FERC Tariff No. 198.22.0) ;
- FERC Tariff No. 199.12.0, local tariff covering interstate transportation from Richmond and Concord, California, to Reno, Nevada (cancels FERC Tariff No. 199.11.0); and
- FERC Tariff No. 200.15.0, local tariff covering Oregon Line interstate transportation (cancels FERC Tariff No. 200.14.0)
- FERC Tariff No. 202.3.0, committed rate tariff covering interstate transportation from El Paso and Diamond Junction, Texas, to the Annex Terminal, Tucson, Arizona (cancels FERC Tariff No. 202.2.0)

SFPP revised FERC Tariff No. 202.3.0 to reduce SFPP's committed rate on the East Line applicable to such rate in accordance with the underlying transportation services agreement.

SFPP makes this filing pursuant to 18 CFR § 342.3, Indexing. The attached Tariff Schedule Changes contains the information required by 18 CFR § 342.3(b), including the rate schedule to be changed, the proposed new rates, the prior rates, the prior ceiling level, and the applicable ceiling level for the movement for the period July 1, 2021 to June 30, 2022.
