Dear Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act ("ICA") and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC" or "Commission"), SFPP, L.P. ("SFPP") submits for filing the following tariffs to be effective July 1, 2026:

- FERC Tariff No. 194.29.0, Rules, and Regulations (cancels FERC No. 194.28.0),
- FERC Tariff No. 195.21.0, local tariff covering interstate transportation from Sepulveda Junction to Watson, California (cancels FERC Tariff No. 195.20.0),
- FERC Tariff No. 196.32.0, local tariff covering interstate transportation from Watson and East Hynes, California to Calnev Pipe Line, LLC (cancels FERC Tariff No. 196.31.0),
- FERC Tariff No. 197.27.0 local tariff covering interstate transportation from El Paso and Diamond Junction, Texas, to Lordsburg, New Mexico, and Tucson and Phoenix, Arizona (cancels Tariff No. 197.26.0),
- FERC Tariff No. 198.32.0, local tariff covering West Line interstate transportation (cancels FERC Tariff No. 198.31.0),
- FERC Tariff No. 199.21.0, local tariff covering interstate transportation from Richmond and Concord, California, to Reno, Nevada (cancels FERC Tariff No. 199.20.0),
- FERC Tariff No. 200.25.0, local tariff covering Oregon Line interstate transportation (cancels FERC Tariff No. 200.24.0), and
- FERC Tariff No. 202.13.0, committed rates tariff covering interstate transportation from El Paso and Diamond Junction, Texas, to Tucson, Arizona (cancels FERC Tariff No. 202.12.0)

SFPP notes that it is revising the committed rates set forth in FERC Tariff No. 202.13.0 in accordance with the provisions of the underlying transportation services agreement.

SFPP makes this filing pursuant to 18 CFR § 342.3, Indexing. The attached Tariff Schedule Changes contains the information required by 18 CFR § 342.3(b), including identification of the rate schedule to be changed, the proposed new rates, the prior rates, the prior ceiling levels, and the ceiling levels that will be applicable for the period July 1, 2026, to June 30, 2027.

SFPP is also revising the Tariffs so that they reference the version of the governing rules and regulations tariff, FERC Tariff No. 194.29.0, that will become effective on July 1, 2026.
