ITEM 320. UNLOADING, PUMP OVER, AND CONNECTION CHARGES	
320.1	In connection with trunk line movement of Crude Petroleum, Carrier will unload Crude Petroleum from tank trucks for a charge of [D]29.92 cents per barrel for all Crude Petroleum received for or on behalf of Shipper.
320.3	A pipeline connection charge of [D]22.39 cents per barrel will be assessed for Crude Petroleum received from Western Refining's Unloading Facility at Carrier's Mason Junction.
320.4	In connection with the transfer of Crude Petroleum received at Kinder Morgan Jackrabbit station to the connection with Centurion Pipeline, Carrier will assess a [U]5.00 cents per barrel charge.

ITEM 330. CHARGE FOR RECEIPT FROM TRUCK LOADING/UNLOADING FACILITIES OF OTHERS	
330.1	A charge of [D]11.49 cents per Barrel will be assessed for Crude Petroleum delivered to Carrier at Wink, Winkler County, Texas from truck unloading facilities that are not owned or operated by Carrier.
330.2	A charge of [U]7.14 cents per Barrel will be assessed for deliveries from Carrier facilities at Wink, Winkler County, Texas to trucks that are not owned or operated by Carrier.
